UNION ELECTRIC COMPANY'S STATEMENTS OF POSITION ON DISPUTED ISSUES

Union Electric Company d/b/a AmerenUE, by and through its counsel, and pursuant to the Order entered by the Commission in this proceeding on April 29, 1999, as modified on June 7, 1999, submits the following statements of position on the Proposed List of General Issues filed by the Commission Staff on July 19, 1999 and on an additional tariff issue not identified on such Proposed List. AmerenUE offers no position with respect to issues on the Staff's Proposed List which are not addressed below.

Rate Design Issues

Class Cost of Service:

AmerenUE's Position:

AmerenUE supports Laclede Gas Company's (Laclede) proposed General Service (GS) rate billing demand concept, but submits that the overall design of such GS rate is flawed in the following respects: (i) it is not based on a proper determination of customer winter peak season billing demands and (ii) it does not reflect the appropriate seasonal differential.

Gas (Supply) Cost Removal From Base Rates:

AmerenUE's Position:

AmerenUE submits that all of Laclede's gas supply costs should be removed from Laclede's base rates and recovered through its Purchased Gas Adjustment (PGA) clause. Notwithstanding the vehicle for recovery of gas supply costs, AmerenUE submits that the demand component of such costs should be seasonally differentiated.

Seasonal Air Conditioning/Structure:

AmerenUE's Position:

AmerenUE opposes Laclede's proposed Seasonal Air Conditioning
Service Rate for the following reasons: (i) Laclede has not
demonstrated a need for such special rate, separate from its GS
Rate and (ii) the structure of such rate is flawed as it is not cost
based and includes an improper cost subsidy.

Tariff Issues

Tariff Description of Service Territory (this issue was not included in Staff's Proposed List of Issues but appears in the testimony of certain parties):

AmerenUE's Position:

AmerenUE concurs with Laclede that the Staff's proposal to require a legal description (township, section and range numbers) by county of Laclede's service territory in its tariff is unnecessary and burdensome.
