On January 23, 2002, Union Electric Company (UE) filed with the Commission one (1) tariff sheet with an issue date of January 23, 2002 and a proposed effective date of February 22, 2002 designed to comply with the Commission's Order Approving Jointly Filed Revised Procedural Schedule (Order) issued January 3, 2002. The Commission found in its Order that UE shall be bound by the following conditions:

Within 20 days of Commission approval of this Stipulation, the Company will file tariff sheet(s) making rates charged on and after April 1, 2002, interim, subject to refund based upon a final non-appealable order of the Commission setting rates in this proceeding. Based upon further discussion, the Company will maintain appropriate records respecting customers on and after April 1, 2002 to facilitate any refund.

UE submitted a revised Table of Contents – Rates tariff sheet adding language indicating that all of the rate schedules listed above are interim, subject to refund beginning April 1, 2002.

The Missouri Public Service Commission Energy Department Staff (Staff) has reviewed the filed tariff sheet and is of the opinion that it was filed in a timely manner; is as agreed to by the Staff and UE in the Jointly Filed Revised Procedural Schedule; and is in compliance with the Commission's Order.
