**REPORT OF
KANSAS CITY POWER & LIGHT COMPANY**

COMES NOW Kansas City Power & Light Company ("KCP&L"), pursuant to the Commission's *Order Directing Kansas City Power & Light Company To Meet With Stakeholders And To Report The Results Of That Meeting* issued in this matter on September 8, 2010 ("*Order*"), and respectfully submits its Report as follows:

1. In accordance with the Commission's *Order*, KCP&L met with interested stakeholders (in person and via conference calls) on September 27, October 4, and October 7, 2010, to discuss its proposal to delay the filing of its next IRP submission from November 5, 2011, to April 1, 2012.

2. The Commission's *Order* provides, in part, that no later than October 8, 2010, KCP&L shall file a report regarding the results of the meeting required by said order.

3. KCP&L reports that the above-referenced meetings have been productive and it appears that a consensus position among KCP&L and the stakeholders regarding the relief requested herein may be achieved. However, additional time is required to reach a determination in that regard. Accordingly, KCP&L respectfully requests that it be allowed to submit a subsequent Report in this matter after its next meeting, which is currently planned for October 15, 2010. As set forth in the Commission's *Order*, any other participant in the meetings would be permitted to file a separate report at the same time.

WHEREFORE, Kansas City Power & Light Company respectfully submits its Report in this matter, and prays that the Commission grant its request to submit a subsequent report after its next meeting currently scheduled for October 15, 2010.
