15	Q. What relevance does this information have pertaining to	accurate
16	quantification of the impact of the tornado on MGE's annual revenue levels?	
17	A. Both the quantification of the tornado's impact found in MGF	E witness
18	Michael R. Noack's direct testimony at pages 9-10 and in my rebuttal test	imony at
19	pages 14-16 are calculated on an annual basis. That is, these calculations ass	sume that
20	customers displaced by the storm will not be taking gas service for at least one ye	ar's time.
21	As rebuilding continues, this assumption may not be true for a significant porti	on of the
22	affected Joplin customer base.

Joplin showing housing rebound

JOPLIN, Mo. —

Nearly half of the 7,500 homes affected by the May 22 tornado are either under repair or are being rebuilt in Joplin, according to city officials. As of the end of last week, city building permits had been filed for repairs, rebuilding or new construction for 3,639 dwellings that include single-family homes, duplexes and apartments. More than half of the permits call for repairs or reconstruction in excess of \$100,000.

"This is a significant number," City Manager Mark Rohr said in a statement. "We are encouraged by the resiliency of our citizens. We also recognize that the city is an active partner with them in this resurgence and are working to ensure positive growth throughout our community."

A post-tornado housing market analysis commissioned by the city indicated that a total of 3,100 housing units needed to be replaced. Of those, 1,400 would be rental dwellings, and of that number, 560 should be "affordable" spaces, the study said. The remaining 1,700 housing units would be owner-occupied homes.
