1. Ameren Missouri filed its *Application* in this case on January 20, 2012.

2. Since the filing of the *Application*, the Company has had several discussions with the Missouri Public Service Commission Staff (Staff) and others. As early as the first technical conference, the Company identified an error in its filing regarding the timing of Evaluation, Measurement and Verification (EM&V).
