**MOTION FOR LEAVE TO FILE THE CORRECTED TRUE-UP
TESTIMONY OF MGE WITNESS MICHAEL R. NOACK**

COMES NOW Missouri Gas Energy ("MGE"), a division of Southern Union Company, and requests leave to file the Corrected True-Up Testimony of Michael R. Noack. In support thereof, MGE states as follows:

1. On July 19, 2004, MGE caused to be filed with the Missouri Public Service Commission ("Commission") in the captioned case, the prepared True-Up Testimony of Michael R. Noack (hereinafter, the "Original Noack Testimony"). As a result of discussions with the Commission's Staff, it has come to MGE's attention recently that a number of entries contained in the true-up schedules attached thereto did not properly process through the revenue deficiency calculation program.

2. Attached to this Motion as an attachment is a copy of the Corrected True-Up Testimony of Michael R. Noack (hereinafter the "Corrected Testimony"). By virtue of this filing, MGE seeks leave of the Commission to file the Corrected Testimony and thereby replace and supercede the Original Noack True-Up Testimony.

3. The filing of the Corrected Testimony will not prejudice any party to this case. To the contrary, the Corrected Testimony is being filed only one day after the Original Noack Testimony was filed and, further, the Corrected Testimony will fully and

accurately set forth MGE's position regarding true-up of the test year revenue requirement. Doing so will clarify the record for the Commission and all parties of record.

WHEREFORE, for good cause shown, MGE requests leave of the Commission to file the Corrected True-Up Testimony of Michael R. Noack and thereby replace and supercede the Original Noack Testimony.
