- 1. KCPL has produced in the above-captioned cases all of the formal discovery it produced for Mr. Drabinski's review in the cases before the Kansas Corporation Commission (KCC) touching on the Iatan 1 and Iatan 2 construction projects. MRA believes that additional information Mr. Drabinski obtained through informal processes cannot be disclosed under the Protective Order issued by the KCC in its proceedings.
