MOTION TO CHANGE PROCEDURAL SCHEDULE

1. Direct testimony in this proceeding is currently due on November 9, 2005, pursuant to the Commission's Order Adopting Procedural Schedule issued September 13, 2005. Several situations, including a serious medical condition, have adversely affected the ability of MGE to meet that deadline. MGE has communicated this to the other parties. After discussion, the parties have agreed on a new schedule that essentially moves the existing milestones approximately two weeks. The dates scheduled for the hearing move approximately three weeks to accommodate the Commission's scheduling calendar. This is only a change in the dates set in the September 13 Order. As the Commission is aware, the issues involving Kansas Pipeline have been bifurcated out and are being held in abeyance pending the outcome of the appeal of GR-96-450, pursuant to previous Commission order, and therefore are not to be addressed or considered pursuant to the schedule being proposed here.

Rebuttal testimony by all parties wishing to file: February 1, 2006
Surrebuttal testimony by all parties wishing to file: March 16, 2006
