**MOTION TO CONSOLIDATE**

COME NOW Socket Telecom, LLC ("Socket") and Spectra Communications Group, LLC ("Spectra"), pursuant to 4 CSR 240-2.110(3) and for their Motion to Consolidate state to the Commission as follows:

1. Socket and Spectra have herein applied for expedited approval of an interim arrangement in connection with a settlement of federal litigation.

2. Socket and CenturyTel of Missouri, LLC ("CenturyTel") have contemporaneously applied for expedited approval of an amendment to interconnection agreement that is similar in content to the interim arrangement that is the subject of this proceeding. The Socket and CenturyTel application has been assigned Case No. TK-2006-0175.

3. Rule 4 CSR 240-2.110(3) provides that "when pending actions involve related questions of law or fact, the commission may order a joint hearing of any or all the matters at issue, and may make other orders concerning cases before it to avoid unnecessary costs or delay."

4. The applications filed by Socket, CenturyTel and Spectra concern the same subject matter and involve the same issues of fact and law. It will be more efficient for all parties

and the Commission to consolidate these actions and hold joint proceedings. Consolidation will avoid unnecessary costs and delay.

WHEREFORE, Socket and Spectra respectfully request the Commission to consolidate this case with Case No. TK-2006-0175.
