On May 20, 1980, and May 21, 1980, the City of Columbia, Missouri, a
municipal corporation, through W. Scott Snyder, City Counselor, and Boone Water &
Waste Treatment Co., Inc., a sewer corporation, through its attorney,
Stephen C. Scott, filed their respective applications to intervene in this matter.
The Commission concludes that both the City of Columbia and Boone Water & Waste
Treatment Co., Inc., are entitled to intervene under 4 CSR 240-2.110(16), and
should be granted leave to do so.

It is, therefore,

ORDERED: 1. That the City of Columbia, Missouri, be, and it hereby is,
granted leave to intervene in this matter.

ORDERED: 2. That Boone Water & Waste Treatment Co., Inc., be, and it
hereby is, granted leave to intervene in this matter.

ORDERED: 3. That this order shall become effective on the date hereof.
