**KANSAS CITY POWER & LIGHT COMPANY'S DEMAND-SIDE PROGRAM**  
**ANNUAL REPORT FOR 2015**

COMES NOW Kansas City Power & Light Company ("KCP&L" or "Company"), and pursuant to 4 CSR 240-20.093(8) and 4 CSR 240-3.161(5), files its Demand-Side Program Annual Report for 2015 and states as follows:

1. Missouri Public Service Commission's ("Commission") Missouri Energy Efficiency Investment Act ("MEEIA") regulations require utilities with one or more approved demand-side programs to file a Demand-Side Program Annual Report no later than 60 days after the end of each calendar year. KCP&L's deadline is 90 days rather than 60 days as outlined in the variance language contained in Appendix H of the November 23, 2015 Non-Unanimous Stipulation and Agreement Resolving MEEIA Filings which states:

5) Variances related to the annual report filing:  
20.093(8)

This rule requires that a utility with one or more approved demand-side program file an annual report no later than 60 days after the end of each calendar year. The Utility would like to extend this 60-day requirement to 90 days, because it believes that at the 60-day point, there will still be a lack of completed available information available to meet the 60 day requirement. Therefore, the Signatories respectfully request a variance to extend the annual report filing requirement to no later than 90 days after the end of each calendar year.

2. Exhibit 1 (**HC**) to this pleading is KCP&L's Demand-Side Program Annual Report for its 2015 MEEIA programs (an Excel Workbook having multiple tabs). Tab 1 of this Exhibit is an index which sets forth the requirements of 4 CSR 240-3.163(5) and indicates where the information responsive to each specific requirement can be found. Exhibit 2 is the Affidavit of Kimberly H. Winslow.

3. As required by the Commission's regulations, the Company is serving a copy of this report on each party to its last MEEIA case, File No. EO-2015-0240.

WHEREFORE, KCP&L requested the Commission accept its Demand-Side Program Annual Report for its 2015 MEEIA programs.
