RE: Notification by the North American Numbering Plan Administrator (NANPA) of Need for Relief Plan Implementation for the 314 and 816 Numbering Plan Area (NPA) Codes

Dear Ms. Payne:

The North American Numbering Plan Administrator ("NANPA"), as the neutral third-party Numbering Plan Area (NPA) relief planner for Missouri and on behalf of the Missouri telecommunications industry ("Industry"), hereby notifies the Missouri Public Service Commission ("Commission")<sup>2</sup> the need for relief in the 314 and 816 NPAs is imminent. In accordance with Paragraph 4 of the Order issued September 25, 2001,

"the Commission's Staff and the technical implementation subcommittees for the 314 and 816 NPAs shall monitor code usage and assignment rates and promptly move the Commission to order implementation of the overlay relief plans when exhaust is imminent or will occur within six months. Any party in this case may likewise move for the Commission's action."

Consistent with the Commission's Order and to update the record, NANPA hereby notifies you that the 314 area code is currently projected to exhaust, absent relief, during the second quarter of 2023, and the 816 area code is currently projected to exhaust, absent relief, during the third quarter of 2024.

*Background:* The 314 NPA, which covers the area of St. Louis and suburbs in neighboring St. Louis County and the 816 NPA, which covers Kansas City, St. Joseph, and all or part of 15 surrounding counties in northwestern Missouri, were the original NPAs which together served the entire state of Missouri when implemented in 1947.

On October 24, 2000, the Commission issued an Order directing the implementation of an all-services overlay for the relief of each of the 314 and 816 NPAs<sup>4</sup> and issued subsequent orders approving the implementation plans of all-services overlays on January 5, 2001, for the relief of the 314 NPA<sup>5</sup> and on February 15, 2001, for the relief of the 816 NPA.<sup>6</sup> On September 25, 2001, due to the Commission's implementation of number conservation measures, the Commission issued an order delaying indefinitely the overlay implementation plans for the 314 and 816 NPAs<sup>7</sup>.

As required by the FCC, NANPA collects area code data, develops projected demand for numbering resources and publishes the projected exhaust of each area code twice a year. In April 2021, NANPA published its semi-annual NRUF (Numbering Resource Utilization/Forecast) and NPA Exhaust Analysis ("April 2021 NRUF Report") which indicated that the 314 NPA complex will exhaust during the second quarter of 2023 and the 816 NPA is projected to exhaust in the third quarter 2024. NANPA convened an Industry meeting via web conference on June 8, 2021 to develop implementation plans included in this letter for both NPAs.8

The 314 and 816 NPAs are scheduled to transition to mandatory 10-digit local dialing by July 15, 2022 as a result of the FCC's Order approving the designation of 988 as the 3-digit abbreviated dialing code for the national suicide prevention and mental health crisis hotline. As a result of this transition, 10-digit local dialing already will be in place prior to the implementation of the new area codes. In addition, the NPA Relief Planning Guidelines were amended to accommodate the impact the national implementation of the 988 abbreviated dialing code and the associated 10-digit dialing transitions will have on area code relief by stating that the only option for relief of these

NPAs is an overlay. Due to this change to the Guidelines, the only option for relief of the 314 and 816 NPA is the already-approved overlays.<sup>11</sup>

Description of the Overlay Implementation Plan: The all-services overlay would superimpose new NPAs over the same geographic area covered by each of the existing 314 and 816 NPAs. NANPA will assign CO codes from the new overlay area code once all assignable CO codes from the 314 and 816 NPAs are exhausted before assignments are made in each of the new overlay area codes. All existing customers would retain their current area code in the overlay area and would not have to change their telephone numbers. The current dialing plan will remain unchanged. The dialing plan is set forth in the following table:

While the January 5, 2001, and February 15, 2001 Orders contain implementation instructions to the industry, many factors have changed in the 20 years since these Orders were approved. Since education for and implementation of 10-digit

local dialing will be complete, the only remaining element for consideration is the implementation of the new NPAs.

The new NPAs that were assigned for both areas after the overlay approval orders are still reserved. The new NPA assigned for 314 the overlay is 557, and the new NPA assigned for the 816 overlay is 975. 12

In preparation for submitting this letter to you, NANPA facilitated a meeting of the Industry on June 8, 2021, during which the Industry, by consensus decision, decided to implement relief for each area code in accordance with a 9-month schedule. The schedule does not include specific dates but rather timeframes to identify the phases of implementation. Adhering to this Industry agreed-upon schedule will allow the new NPAs to be implemented at least six months prior to the projected exhaust of the 314 and 816 NPAs.<sup>13</sup> The Industry will select specific dates at a subsequent implementation meeting to ensure they do not interfere with certain holidays, high traffic days, network freeze periods, or conflict with other overlay implementations occurring across the country. NANPA will facilitate this Industry meeting approximately 60 days from the date of this letter, unless directed otherwise by the Commission.

The following are activities considered by the Industry for an Implementation Schedule for each of the All-Services Overlays:

Adhering to an Industry-proposed implementation schedule will avoid the denial or delay of service to telecommunications providers' customers due to the unavailability of CO codes.

The original Orders directed the industry to form a planning committee to implement the new area codes. The following table outlines the methods and processes the industry typically utilizes in current relief projects for implementation of an initial overlay when mandatory 10-digit dialing is already in place; however, these could be modified during the actual implementation:
