1.0 Summary

Foundation installation began during April and was the focus of activity for the month in anticipation of turbine deliveries beginning in May. Progress continued on permitting for the project, as Empire had two meetings with the U.S. Fish and Wildlife Service regarding the Habitat Conservation Plan. Vestas provided updated delivery information indicating delays in tower deliveries from India and Malaysia, resulting in a change in the anticipated substantial completion date. Despite delivery delays, the project is on schedule for completion before December 31, 2020.

2.0 Safety

As of April 30, 2020, there are 149 personnel on site, and cumulative man-hours worked are 57,476. There have been no OSHA-recordable incidents to date. The project reports the following safety incidents for the month of April:

Near misses:

• A loaded concrete truck sunk into a soft spot on a public road. The batch had to be dumped to retrieve the truck.

Property damage:

- A local resident ran a stop sign and collided with an aggregate truck.
- An unoccupied bulldozer was vandalized. An object was thrown through the cab glass.
- A buggy hauling aggregate ran into a gate. The gate was restored by the fencing subcontractor.
- An aggregate truck and a concrete truck travelling in opposite directions on a narrow road made contact with their side view mirrors.
- Two incidents of broken window on equipment being hauled on trailers. The windows were broken by gravel thrown by the truck towing the trailer.
- Two incidents of broken windows on equipment due to wind. Doors were not properly secured, were caught by wind and slammed, causing the glass to break.
- Minor damage to a rubber-tired crane as it maneuvered out of mud onto a timber crane mat.
- A forklift window broke as it was being driven down a public road. Cause of the damage is unknown.
- A rebar truck and a dump truck travelling in opposite directions on a narrow road made contact with their side view mirrors.

• A dump truck was passing a street sweeper on a public road. As it passed, one of its tires threw up a rock, breaking a window on the sweeper.

First aid:

• Foot contusion and abrasion: A worker assisting with unloading cold patch from a tilt trailer got his foot pinched between the trailer and a skid steer. First aid was administered by the on-site medic. Proper loading and unloading techniques and pinch point hazards were reviewed with all crews.

Mortenson has continued to revise its site-specific coronavirus plan, as required. To date, there have been no positively identified cases of COVID-19 among project personnel.

3.0 **Project Schedule**

Based on the change order to the EPC contract between Kings Point Wind, LLC and Mortenson, substantial completion is scheduled to be achieved on December 5, 2020, marking the commencement of commercial operation. This date has been changed to December 9 due to a delay in deliveries of turbine towers from India and Malaysia due to measures taken by the governments of those nations in response to the coronavirus public health emergency. This change in substantial completion date has no impact to the schedule established in the Purchase and Sale Agreement.

4.0 Development Activities

The most significant development activity for the month was the continuing work on the permits from the U.S. Fish and Wildlife Service. During April, Empire (on behalf of the Project), met twice with the Service regarding the Habitat Conservation Plan. Empire is addressing the Service's feedback to the latest draft of that plan and anticipates returning another draft to the plan to the Service in early June. The Project also continued its bi-weekly coordination meetings with the Missouri Department of Transportation.

5.0 Construction Activities

This is the status of construction activities as of the end of April:

 - Receive main power transformer at substation
 - Begin hauling and spotting of transmission structures
- Turbine erection:
 - Begin receiving and offloading of turbine components
