**AMERENUE'S RESPONSE TO  
ORDER TO FILE STATUS REPORT**

**COMES NOW** Union Electric Company d/b/a AmerenUE (AmerenUE or the Company), and for its Status Report in response to the Missouri Public Service Commission's (Commission) *Order To File Status Report* (Order), states as follows:

1.       On June 11, 2009, the Commission issued its Order requiring AmerenUE and the Commission's Staff to file a report no later than June 25, 2009 stating: a) whether AmerenUE has provided the updated reliability study described in the Commission's April 15, 2009 order; and b) how the parties intend to proceed.
2.       On May 29, 2009, AmerenUE submitted its updated reliability study to Staff.
3.       The one issue remaining in this case is resolution of AmerenUE's pursuit of refunds from Missouri Pipeline Company (MPC) and Missouri Gas Company (MGC) (k/n/a MoGas Pipeline LLC) for the overpayment of gas costs. Staff recommended this case remain open pending Staff's final recommendation concerning potential refunds.
4.       AmerenUE does not object to the case remaining open for that purpose.

WHEREFORE, AmerenUE submits this pleading in response to the Commission  
Order of June 11, 2009.
