## SPECTRA COMMUNICATIONS GROUP, LLC D/B/A CENTURYTEL'S NOTICE OF ADDITIONAL AMENDMENT TO APPLICATION FOR COMPETITIVE CLASSIFICATION

COMES NOW Spectra Communications Group, LLC d/b/a CenturyTel ("Spectra"), pursuant to Commission Rule 4 CSR 240-2.080, and for its Notice of Additional Amendment to Application for Competitive Classification respectfully states as follows:

1. On May 17, 2007, Spectra filed its verified Application for Competitive Classification pursuant to Section 392.245.5 RSMo. Cum Supp. 2005, and revised tariff sheets with an effective date of June 16, 2007, initiating the above-referenced matter. Pursuant to the original Application, Spectra requests that the Commission conduct a 30-day competitive classification review pursuant to Section 392.245.5(6) RSMo. and approve Spectra's Application for Competitive Classification for all of its residential services, other than exchange access service, for the following exchanges: (a) Brunswick, (b) Cameron, (c) Golden City, (d) Greenfield, (e) Lawson, (f) Mountain Grove and (g) Sarcoxie; and for all of its business services, other than exchange access services, in the Spectra exchange of Mount Vernon.

- 2. On May 22, 2007, the Commission issued its *Order Directing Notice*, *Establishing Procedural Schedule*, and *Reserving Hearing Date* in this matter. No party has filed an application to intervene in this proceeding.
- 3. On June 1, 2007, pursuant to discussions with the Staff of the Commission and the Office of the Public Counsel, Spectra filed its Notice of Amendment to Application for Competitive Classification in this matter, deleting its specific request for competitive classification for Business Services in its Mount Vernon exchange.
- 4. Pursuant to additional discussions with the Staff of the Commission, Spectra hereby notifies the Commission and the parties that it is further amending the relief requested in this matter, by deleting the following specific request for competitive classification at this time:

Residential Services in its Mountain Grove exchange.

5. As stated in its previous Notice, Spectra will be filing substitute tariff sheets in this case and Tariff File No. JI-2007-0840 to effectuate the above amendment to its requested relief.

WHEREFORE, Spectra Communications Group, LLC d/b/a CenturyTel respectfully submits its Notice of Additional Amendment to its previously filed Application for Competitive Classification.
