**NOTICE OF AGREEMENTS WITH SPRINT PCS AND NEXTEL
AND REQUEST TO SEVER CASES
AND SUSPEND PROCEDURAL SCHEDULE**

COME NOW Petitioners and Sprint Spectrum L.P ("Sprint PCS") and NEXTEL Communications, Inc. ("NEXTEL") and for their joint notice of pending agreements and request to sever cases and suspend procedural schedule, state to the Missouri Public Service Commission ("Commission") as follows:

1. **Agreements.** Petitioners have reached a negotiated agreement with Sprint PCS and NEXTEL, and the parties are in the process of finalizing and executing Traffic Termination Agreements.

2. **Request to Sever Proceedings.** Negotiated agreements between the Petitioners and Sprint PCS/NEXTEL are expected to be filed soon. At such time as the last agreement is executed and filed with the Commission, Petitioners intend to file a motion to dismiss their Petitions for Arbitration with Sprint PCS and NEXTEL in Case Nos. TO-2006-0148 and TO-2006-0149, respectively. Therefore, Petitioners and Sprint PCS/NEXTEL respectfully request that these two cases be severed from the consolidated arbitration proceeding captioned above.

3. **Request to Suspend Proceedings.** Petitioners and Sprint PCS/NEXTEL respectfully request that the Commission suspend the procedural schedule in Case Nos. TO-2006-0148 and TO-2006-0149 while the negotiated agreements are being finalized.

WHEREFORE, Petitioners and Sprint PCS/NEXTEL respectfully request that the Commission: (1) take notice that negotiated agreements between Petitioners and Sprint PCS/NEXTEL are being finalized and will be filed with the Commission; (2) sever Case Nos. TO-2006-0148 and TO-2006-0149 while the agreements are being finalized; (3) suspend the procedural schedule in Case Nos. TO-2006-0148 and TO-2006-0149 while the negotiated agreements are being finalized; and (4) grant such other relief as is reasonable in the circumstances.
