Dear Mr. Rauch:

On behalf of Telco Holdings, Inc. d/b/a Dial & Save ("THP" or "Company"), this letter is to notify the Commission of the Company's intention to change its name to Teleglobe Business Solutions Inc. A copy of the Certificate of Authority to Transact Business in the State of Missouri under the new name is attached as Exhibit A. Additionally, the requisite adoption notice and Missouri P.S.C. Tariff No. 1 revised title page are attached as Exhibit B and Exhibit C, respectively.

By way of background, THI is authorized to provide intrastate interexchange and local exchange telecommunications services in Missouri pursuant to the Commission Orders in Docket Nos. TA-95-298 (June 29, 1995) and TA-97-7 (June 6, 1997), respectively. Including Missouri, THI is authorized to provide resold intrastate interexchange telecommunications services in forty-eight (48) states and intrastate local exchange telecommunications services in twenty-seven (27) states, pursuant to certification, registration, or, where applicable, deregulation. THI also holds an international Section 214 authorization to provide global facilities-based and global resale telecommunications services to all international points.¹

THI has determined that the name change from Telco Holdings, Inc. to Teleglobe Business Solutions Inc. will be a valuable step in developing its telecommunications services and in implementing its ongoing business plan. Specifically, the name change will facilitate consolidation of business customers under a single brand name in the Teleglobe corporate family of telecommunications service providers, thereby strengthening the Company's position in the telecommunications market and increasing the efficiency of operations through economies of scope and scale. The name change will not in any way inconvenience or cause harm to THI's customers.

Upon review of Missouri statutes and Commission rules, it is the understanding of the Company that prior Commission approval is not required for the proposed name change. Therefore, absent receipt of written notification to the contrary, the Company will, within thirty (30) days, proceed on the understanding that no approval or other formal action with respect to the name change is required by the Commission.

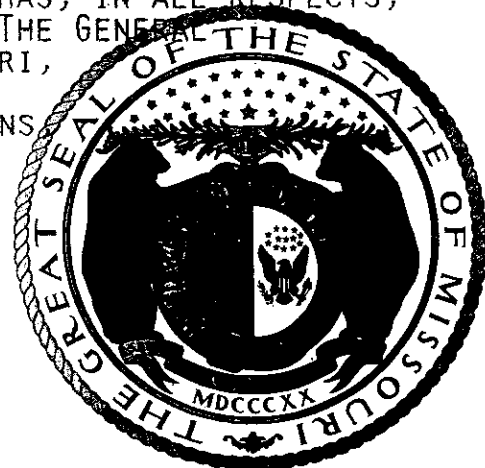
