The current proposed effective date of the tariff which is the subject of this matter is November 20, 2009.
- 2. Undersigned counsel has spoken with counsel for AT&T and Staff regarding this matter, and communicated Neutral Tandem's belief and intention that these revisions will likely resolve all issues, and that the current proposed effective date will allow adequate time for the review and processing of the proposed tariff, without the need for any prehearing or other formal procedures before the Commission.

3. Neutral Tandem requests that the Commission hold this matter in abeyance while the parties continue efforts to resolve this matter prior to the current proposed effective date of November 20, 2009.

WHEREFORE, Neutral Tandem respectfully requests the Commission accept this Status Report and take no further action in this matter until requested by one or more parties.
