County, Missouri.

SUPPLEMENTAL ORDER

On March 21, 1980, Southwest Sewer Corporation filed with this Commission its application to construct and operate a sewer system in Jasper County, Missouri. Such case was heard on October 24, 1980, along with two companion cases. One of the cases was dismissed and the other was continued until late-filed exhibits are made available to the Commission. Upon consideration of the application in Case No. SA-80-230, the exhibits offered in support thereof and the recommendations of its staff, the Commission granted a certificate of convenience and necessity authorizing the construction and operation of such sewer system on November 24, 1980.

It is the Commission's opinion that a supplemental order be issued in support and furtherance of the previous order.

It is, therefore,

ORDERED: 1. That the Southwest Sewer Corporation file with this Commission within sixty (60) days of the date of this order its rules and regulations regarding the rendering of service to its customers.

ORDERED: 2. That the Southwest Sewer Corporation maintain continuing property records.

ORDERED: 3. That this order shall become effective on the date hereof.
