**LIBERTY UTILITIES (MISSOURI WATER) LLC’S**  
**NOTICE OF INTENDED CASE FILING**

COMES NOW Liberty Utilities (Missouri Water) LLC (“Liberty Water”), pursuant to Commission Rule 20 CSR 4240-4.017, and files this Notice of Intended Case Filing and respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1. Liberty Water is a Missouri limited liability company with its principal office located at 602 Joplin Street, Joplin, Missouri, 64801, and provides water and sewer services to customers in its Missouri service areas, as certificated by the Commission. Liberty Water is a “water corporation,” a “sewer corporation,” and a “public utility,” as those terms are defined by RSMo. §386.020 and, therefore, is subject to the general regulatory jurisdiction of the Commission as provided by law.

2. Commission Rule 20 CSR 4240-4.017(1) provides, in part, as follows:

Any person that intends to file a case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case. Such notice shall detail the type of case and issues likely to be before the commission and shall include a summary of all communication regarding substantive issues likely to be in the case between the filing party and the office of the commission that occurred in the ninety (90) days prior to filing the notice.

3. It is Liberty Water’s intent to file an Application for authority to issue long-term, unsecured debt within the next 60-180 days. Issues likely to be before the Commission in the upcoming financing case include those concerning the rate, terms, and conditions related to the proposed financing.

4. No communications regarding substantive issues likely to be in this case have taken place between Liberty Water and the office of the Commission in the ninety (90) days prior to the filing.

WHEREFORE, Liberty Water submits to the Commission and its Secretary this Notice of Intended Case Filing.
