THIRTEENTH STATUS REPORT

COMES NOW the Director of the Manufactured Housing and Modular Units Program of the Public Service Commission ("Director," "Commission"), by and through counsel, and for its response to the Commission's *Order Directing Notice to Homeowners* of August 17, 2004 and *Notice of Complaint Involving Manufactured Housing Setup Contractor and Order Directing Filing* of October 13, 2004, states the following:

- 1. On August 27, 2004, the Director sent notices to 124 homeowners identified in the list filed on July 28, 2004, by Coachman Homes of Eureka, Inc., (Coachman).
- 2. Twenty-eight responses were received and out of those responses, 27 homeowners have requested an inspection of their manufactured home.
- 3. Staff and Coachman performed 27 inspections, and it has been determined that 26 of those inspections revealed deficiencies in the anchoring and tie down of those homes. The deficiencies observed include the use of improper anchors for soil type, inadequate strapping and improper placement and number of anchors for the home.
 - 4. Coachman has repaired all of the homes identified as needing repair.

- 5. The Hatfield manufactured home has been removed and all debris has been disposed. Staff was unable to verify if Ms. Hatfield has received her check, but Coachman's counsel indicated that the check was mailed Friday, March 12, 2005.
- 6. Staff submitted an invoice to Coachman for recovery of inspection costs incurred in this case. Coachman's counsel indicated that the check was mailed Monday, March 14, 2005.

WHEREFORE, the Director of the Manufactured Housing and Modular Units Program of the Public Service Commission hereby respectfully submits this status report.
