JOINT MOTION FOR EXPEDITED TREATMENT OF APPLICATION FOR CHANGE OF NAME

Joint Movants Aquila, Inc. dba Aquila Networks – L&P, Aquila, Inc. dba Aquila Networks – MPS (collectively, "Aquila Networks"), and Great Plains Energy Incorporated through undersigned counsel and pursuant to 4 CSR 240-2.080(16), hereby request expedited approval from the Missouri Public Service Commission ("Commission") of the attached Change of Name application and tariff sheets included therein (designated **Exhibit 1** and incorporated herein by reference) submitted this date by Movants, in order to permit Aquila Networks to begin doing business as KCP&L Greater Missouri Operations Company on the anticipated closing date of the transactions authorized by the Commission in Case No. EM-2007-0374.

In support of this Motion, Movants respectfully state as follows:

- 1. As fully set forth in the Cover Letter of Exhibit 1, Movants are filing the attached Adoption Notices and Revised Title Pages to their existing tariffs to effectuate the change of name of Aquila Networks to Aquila, Inc. dba KCP&L Greater Missouri Operations Company.
- 2. While the attached tariff sheets reflect a 30-day effective date (Issued date of July 2, 2008 and an Effective date of August 1, 2008), Movants are filing this Motion for Expedited Treatment, requesting that the Commission approve the name change and such tariffs to be effective on July 14, 2008, to coincide with the closing date of the transactions authorized by the Commission in its Report and Order in Case No. EM-2007-0374 (issued July 1, 2008, effective July 11, 2008).

3. Pursuant to 4 CSR 240-2.080(16), Movants respectfully seek expedited treatment

and approval of such name change application and the tariff sheets included therein and request

that the Commission act before July 14, 2008, in approving and allowing said tariff sheets to be

effective on that date, in order to permit Aquila Networks to utilize the name Aquila, Inc. dba

KCP&L Greater Missouri Operations Company. Although the failure of the Commission to

grant this motion for expedited treatment or approve the name change application will not have a

negative impact on customers or delay the closing date of the acquisition transaction, approval of

this request will benefit Aquila Networks customers in so far as the name change will be

consistent with other public messages customers will be receiving through news media about the

completion of the acquisition. This pleading was filed as soon as it could have been, as the

Commission's Report and Order in Case No. EM-2007-0374 was issued on July 1, 2008.

WHEREFORE, Movants respectfully request that the Commission grant this Motion for

Expedited Treatment and approve the name change and subject tariffs to be effective on July 14,

2008.
