MOTION TO CLOSE DOCKET

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company) and for its Motion to Close Docket states as follows:

1. On January 2, 2008, the Missouri Public Service Commission (Commission) issued an order directing the Missouri Public Service Commission Staff (Staff) to investigate the responses of AmerenUE, The Empire District Electric Company (Empire) (Case No. EO-2008-0215), Kansas City Power & Light Company (KCP&L) (Case No. EO-2008-0219), and Aquila, Inc. (Aquila) (Case No. EO-2008-0220) to the December 2007 ice storm.

2. On April 3, 2008, Staff filed an initial report of its investigation with the Commission, followed by a Final Report submitted on June 17, 2008, containing eight (8) recommendations on how AmerenUE could improve its response in future storms.

3. On August 15, 2008, AmerenUE filed its Response to Staff's Report of June 17, 2008.

4. The Commission issued an order on September 9, 2008, directing AmerenUE to provide Staff with additional information specifying its progress in complying with Staff's recommendations. The same order also instructed Staff to file a supplemental report describing the Company's compliance.

5. On January 9, 2009, Staff filed its Supplemental Report, including a Memorandum stating that “from an overall perspective, AmerenUE has achieved compliance with all but one of Staff’s recommendations or is taking appropriate action to do so.”

6. On February 4, 2009, the Commission issued orders in the Empire, KCP&L and Aquila dockets accepting Staff’s reports and closing the cases.

WHEREFORE, AmerenUE asks that the Commission issue an order closing this docket.
