MOTION TO CORRECT ORDER *NUNC PRO TUNC*

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or the “Company”), and hereby requests the Commission to correct a typographical error in its March 8, 2017, *Order Further Modifying 2012 Report and Order* (“Modification Order”) and, as reasons for its request, states as follows:

INTRODUCTION

1. The Joint Motion approved by the Modification Order essentially requested that the timeline for a further formal filing in this docket respecting Ameren Missouri’s continued regional transmission organization participation be extended from November 15, 2017 to March 15, 2020, as noted at page 1 of the Modification Order.

2. However, in ordered paragraph 2.D (at page 4), the Modification Order incorrectly directs Ameren Missouri to file a pleading by “November 15, 2020.” The Modification Order correctly references the March 15, 2020 date at page 1 (as noted), and in ordering paragraphs 2.I (page 5) and 2.S (page 7).

3. Because the reference to November 15, 2020, appears to merely be a typographical error, it is appropriate for the Commission to correct it *nunc pro tunc* to reflect the original intent of the Modification Order.

4. Ameren Missouri is authorized to indicate that the other Joint Movants support this motion.

WHEREFORE, Ameren Missouri requests the Commission to correct the Modification Order as outlined herein.
