## MOTION TO MODIFY PROCEDURAL SCHEDULE

COME NOW KCP&L Greater Missouri Operations Company ("GMO"), and files a Motion to Modify Procedural Schedule with the Missouri Public Service Commission ("Commission") and states as follows:

- 1. On June 1, 2012, the Commission issued an *Order Granting Joint Motion to Modify Procedural Schedule*, by which the Commission ordered and evidentiary hearing to be held June 18 20 and June 25, 2012 in this matter.
- 2. Due to the Parties continued settlement discussions, and ongoing attempts to narrow the issues and provide a better roadmap for hearing, GMO is requesting that the evidentiary hearing be moved to July 9-11, 2012.
- 3. The Office of the Public Counsel, the Missouri Department of Natural Resources, Missouri Gas Energy, Missouri Industrial Energy Consumers, Union Electric Company d/b/a Ameren Missouri, Natural Resources Defense Council, Renew Missouri, Sierra Club, Wal-Mart Stores, Inc. and Sam's East, Inc. have indicated that they do not oppose moving the hearing dates to July 9-11, 2012. Counsel for Midwest Energy Users' Association indicated that July 9 and parts of July 10, 11 are acceptable.

4. The Missouri Public Service Commission Staff does not oppose the new hearing dates so long as the tariffs filed with GMO's Application are extended by at least an additional thirty (30) days, or such other period the Commission finds appropriate, and that the Commission further waive rule 4 CSR 240-20.094(3) and extend the date for its decision, until at least ten (10) days before the date to which the tariff sheets are suspended to allow a decision to be in effect before the tariff sheets take effect.

**WHEREFORE**, GMO files this Motion requesting the Commission extend the dates of the evidentiary hearing.
