**MOTION TO RESCHEDULE PREHEARING CONFERENCE**

Southwestern Bell Telephone Company<sup>1</sup> respectfully requests the Missouri Public Service Commission to move the prehearing in this case from September 18, 2002 to September 27, 2002. Rescheduling the prehearing is necessary to avoid a conflict with a previously scheduled mediation in another case pending before the Commission. In support of this Motion, Southwestern Bell states:

1. In its August 30, 2002 Order Setting Prehearing Conference, the Commission scheduled a prehearing in this case for Friday, September 27, 2002 at 10:00 a.m.
2. The scheduling of the prehearing on this date conflicts with a previously scheduled formal mediation session Southwestern Bell has with another carrier in Case No. TC-2002-1104.
3. In order to avoid the conflict so that necessary company representatives can attend the prehearing and address issues the Commission designated for consideration, Southwestern Bell requests the Commission to reschedule the prehearing for Friday, September 27, 2002 at 10:00 a.m.
