

**NOTICE OF NAME CHANGE OF RESPONDENT**

COMES NOW Aquila, Inc., f/k/a UtiliCorp United Inc., d/b/a Aquila Networks – MPS, f/k/a Missouri Public Service, Respondent in the captioned matter, by and through counsel, and states to the Missouri Public Service Commission as follows:

Effective March 15, 2002, UtiliCorp Renaming Corporation, a Delaware corporation, merged with and into UtiliCorp United Inc. ("UtiliCorp"), a Delaware corporation, as authorized by the Missouri Public Service Commission in its Case No. EM-2002-297. UtiliCorp was the surviving corporation. At the time of the merger, UtiliCorp changed its name to Aquila, Inc. ("Aquila") in accordance with §253 of the Delaware General Corporation Law. As of March 18, 2002 and hereafter, Aquila will operate in the area formerly served by Missouri Public Service using the name Aquila Networks – MPS. Consequently, all subsequent pleadings by the Respondent in this case will be filed by Aquila d/b/a Aquila Networks – MPS.
