RE: Case No. GR-2013-0422, Missouri Gas Energy

Attached for filing on behalf of Missouri Gas Energy is an electronic version of P.S.C. MO. No. 6, Twenty-Ninth Revised Sheet No. 24.3, canceling Twenty-Eighth Revised Sheet No. 24.3. This tariff sheet bears an issue date of October 17, 2013, and a proposed effective date of November 1, 2013.

By this filing, MGE proposes to make an adjustment to the Purchased Gas Adjustment (PGA) Rate as permitted under the provisions of Sheet No. 15 of MGE's tariff. MGE is proposing to adjust the Current Cost of Gas Factor (C.C.G.) and Actual Cost Adjustment Factor (A.C.A.).

The proposed PGA Rate of \$0.55962 reflects a decrease of \$0.00567 per Ccf over the PGA Rate currently in effect of \$0.56529. The change in the PGA Rate reflects an increase in the C.C.G. Factor of \$0.03384 per Ccf, from the current C.C.G. Factor of \$0.51969 to the proposed amount of \$0.55353. Also, the proposed PGA Rate reflects a decrease in the A.C.A. Factor of \$0.03951 per Ccf, from the current A.C.A. Factor \$0.04560 to the proposed amount of \$0.00609.

The proposed adjustment has the overall net effect of decreasing revenues in MGE's service area by approximately \$3,181,271 annually. This represents an overall 1.00% decrease in revenues.

Workpapers supporting the calculations performed in developing the proposed changes have been provided this date under a separate cover letter to the Commission's Staff and The Office of the Public Counsel.
