**MOTION TO WITHDRAW**

COMES NOW, NPG Cable, Inc. d/b/a St. Joseph Cablevision, Inc. ("NPG Cable") and, by and through its undersigned counsel, hereby seeks to withdraw as a party to the above-captioned proceeding. NPG Cable was made aware of this proceeding through a phone call to NPG Cable's outside counsel on the afternoon before the deadline set for parties to intervene in this proceeding. NPG Cable scrambled to intervene so that it could monitor and understand the allegations and issues in the proceeding that related to NPG Cable's VoIP service. Because CenturyTel in its application for competitive status implied that NPG Cable's service in the Savannah exchange constituted something other than voice over internet protocol service, NPG Cable sought to correct the record by filing its Objections and Recommendations.

Since the date on which NPG Cable intervened in this proceeding, NPG Cable and its counsel have had several discussions with the Commission staff explaining NPG Cable's VoIP service. NPG Cable has also provided information to Spectra Communications Group, LLC d/b/a/ CenturyTel in response to a set of data requests, despite objecting to the requests on several grounds. At this point, however, NPG Cable has determined that its interests will be adequately protected if it withdraws as a party to this proceeding. The withdrawal of NPG Cable should not prejudice any other party in any way.

WHEREFORE, NPG Cable respectfully requests the Commission to grant this Motion to Withdraw.
