**MOTION TO CORRECT ORDER NUNC PRO TUNC**

COME NOW Southern Missouri Gas Company, L.P. d/b/a Southern Missouri Natural Gas (“SMNG” or “Company”), the Staff (“Staff”) of the Missouri Public Service Commission (“Commission”) and the Office of the Public Counsel (“OPC”) (collectively the “Parties”) and for their Motion To Correct Order Nunc Pro Tunc respectfully state as follows:

1. On January 19, 2011, the Commission issued its Order Approving Small Company Rate Increase And Approving Tariff (“Order”) in the above-styled case, said Order to be effective February 1, 2011.

2. The last sentence appearing at the bottom of page 2 of the Order contains an inadvertent reference to optional service having a “flat customer” charge only, when, in fact, optional service has a “volumetric” charge only. Accordingly, the Parties respectfully suggest that said sentence should read as follows: “Optional service has a volumetric charge only; others have both the flat customer charge and a volumetric charge.”

WHEREFORE, for the foregoing reasons, the parties respectfully request that the Commission's January 19, 2011 Order issued in this matter be corrected *nunc pro tunc* as stated herein.
