NOTICE OF COMPLIANCE

COMES NOW Missouri-American Water Company (MAWC), and, in compliance with the Order issued by Missouri Public Service Commission (Commission), states as follows:

1. On July 11, 2012, the Commission approved the Unanimous Stipulation and Agreement that resolved all issues in this matter. On that same day, Missouri-American Water Company ('MAWC') filed tariff sheets to be in compliance with the Commission's order.

2. On July 19, 2012 (effective July 20, 2012), the Commission issued its Order Approving Tariff Filing In Compliance With Commission Order.

3. The Order requires MAWC to file notice that it has closed on the subject property.

4. MAWC hereby notifies the Commission that the assets were transferred on August 10, 2012.

5. The Order also states that MAWC's tariff sheets, Tariff Tracking Numbers YS-2013-0033 and YW-2013-0034, "are approved to become effective on the date Missouri-American files its notice of closing on the acquisition of the subject water and sewer systems."
