NOTICE OF LIKELY CONTESTED CASE

In accordance with 4 CSR 240-4.020(2), Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) gives notice it may file one or more applications seeking authority (a) for Ameren Missouri to sell or transfer a portion of its distribution and related electric service facilities, including customers and locations served by those facilities, to Three Rivers Electric Cooperative (“Three Rivers”) in exchange for distribution and related electric service facilities owned by Three Rivers, including customers and locations served by those facilities, and (b) for an amendment of the existing territorial agreement between Ameren Missouri and Three Rivers. Issues that may arise in the case include valuation of the assets Ameren Missouri proposes to transfer to Three Rivers, valuation of the assets Ameren Missouri will receive in exchange, whether the proposed sale of Ameren Missouri’s facilities is detrimental to the company and its customers, and whether the proposed transfers and amendment to the territorial agreement are in the public interest.
