APPLICATION FOR APPROVAL OF AN AMENDMENT TO THE INTERCONNECTION AGREEMENT BETWEEN CENTURYTEL OF MISSOURI, LLC d/b/a CENTURYLINK AND SOCKET TELECOM, LLC

COMES NOW Socket Telecom, LLC ("Socket") pursuant to Section 252(e) of the Telecommunications Act of 1996 ("the Act") and 4 CSR 240-3.513(6)(c), and for its Application for Approval of an Amendment to the Interconnection Agreement Between CenturyTel of Missouri, LLC d/b/a CenturyLink and Socket Telecom, LLC, hereby requests that the Commission approve the Amendment attached hereto in conjunction with the settlement of matters in dispute in Commission Case No. TC-2008-0225.

I. Parties

1. Socket is a certificated competitive local exchange company in the State of Missouri. 3. CenturyTel of Missouri, LLC d/b/a CenturyLink ("CenturyLink") is a limited

liability company organized and existing under the laws of the State of Louisiana and authorized

to conduct business in the State of Missouri. It is a public utility subject to the jurisdiction of the

Commission and provides telecommunications services in its service areas within the State of

Missouri under authority granted and tariffs approved by the Commission. It is an incumbent

local exchange carrier as defined in Section 251(h) of the Telecommunications Act of 1996 and a

large local exchange carrier as defined in Sections 386.020, 392.361, and 392.245 R.S.Mo.

II. Allegations of Fact

- 5. CenturyLink and Socket are currently interconnecting and exchanging traffic pursuant to the terms of the interconnection agreement (the Agreement) approved by the Commission in Case No. TO-2006-0299.
- 6. Socket presents to this Commission for approval an Amendment to the Interconnection Agreement Under Sections 251 and 252 of the Telecommunications Act of 1996 between CenturyTel of Missouri, LLC d/b/a CenturyLink and Socket Telecom, LLC, ("Amendment to Interconnection Agreement") attached hereto as **Exhibit B**, negotiated and executed pursuant to the terms of the Federal Act. All issues have been successfully negotiated and agreed upon. No arbitration of any issue is required. Both parties have signed the document. Upon approval of this Amendment and an identical amendment contemporaneously submitted for approval concerning the interconnection agreement between Socket and Spectra Communications Group, LLC d/b/a CenturyLink, the parties will be able to dismiss all claims in Commission Case No. TC-2008-0225 pursuant to settlement.
- 7. Socket seeks the Commission's approval of the Amendment to Interconnection Agreement with CenturyLink, consistent with the provisions of the Federal Act and Missouri law. Implementation of the Amendment to Interconnection Agreement complies fully with § 252(e) of the Federal Act because it is non-discriminatory and consistent with the public interest, convenience and necessity. The Amendment to Interconnection Agreement will promote

diversity in providers and will lead to increased customer choices for telecommunications services.

- 8. Socket respectfully requests that the Commission grant approval of the Amendment to Interconnection Agreement without change, suspension, or other delay in implementation. This is a bilateral document, entered into as a result of negotiations and compromise between competitors, and Socket believes that procedures for review of the document should be designed to permit expeditious implementation thereof, and that interventions should be strictly limited consistent with the scope of review specified by the Federal Act and the Commission's applicable rules.
- 9. The Applicable standard of review is set forth in § 252(e) of the Federal Act and provides as follows:

(e) APPROVAL BY STATE COMMISSION –

- (1) APPROVAL REQUIRED Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the State commission. A State commission to which an agreement is submitted to shall approve or reject the agreement, with written findings as to any deficiencies.
- (2) GROUNDS FOR REJECTION The State commission may only reject
 - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that
 - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
 - (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience and necessity.
- 10. Socket does not have any pending actions or unsatisfied final judgments or decisions against it from any state or federal agency or court which involve customer service or

customer rates, which action, judgment or decision has occurred within three years of the date of this Application.

11. Socket does not have any overdue annual reports or assessment fees.

WHEREFORE, Socket respectfully requests that the Commission approve the Amendment to Interconnection Agreement Under Sections 251 and 252 of the Telecommunications Act of 1996 Between CenturyTel of Missouri, LLC d/b/a CenturyLink and Socket Telecom, LLC, and grant additional relief as the Commission deems proper and reasonable.
