COMES NOW NuVox Communications of Missouri, Inc. ("NuVox") and for its
Application to Intervene states to the Commission:

1. NuVox is a competitive telecommunications company duly incorporated and existing under and by virtue of the laws of the State of Delaware and authorized to do business in the State of Missouri as a foreign corporation. Its principal offices are currently located at 16090 Swingley Ridge Road, Suite 500, Chesterfield, Missouri 63017. NuVox is an authorized provider of intrastate local exchange and interexchange telecommunications services in Missouri under certificates granted and approved by the Commission. NuVox is also an authorized provider of interstate telecommunications services in Missouri under the jurisdiction of the Federal Communications Commission.

3. On or about August 15, 2002, the Commission issued an Order Establishing Case to monitor the status of bankrupt telecommunications carriers, including WorldCom and its subsidiaries.

4. NuVox seeks to intervene in this proceeding because the case could affect NuVox's interests as both a wholesale customer of WorldCom and a wholesale provider of services to WorldCom.

5. NuVox's interests as a telecommunications company are different from those of the general public. Furthermore, NuVox's intervention in this proceeding is in the public interest because of NuVox's interest in preserving the integrity of the telecommunications system and because of its expertise in the telecommunications industry. NuVox does not support or oppose any particular position at this time as it lacks sufficient information.

WHEREFORE, NuVox respectfully requests that the Commission issue an Order granting NuVox's Application to Intervene.


