**JOINT MOTION TO HOLD PROCEEDING IN ABEYANCE**

COME NOW MultiBand, Inc. (Applicant herein) and Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri (AT&T Missouri), collectively referred to as "Moving Parties", by and through counsel of record, and jointly and respectfully request the Commission or the Regulatory Law Judge to hold this proceeding temporarily in abeyance, pending further notice from the Parties as discussed below.

On or about October 25, 2006, MultiBand and AT&T Missouri reached an agreement that is designed to resolve the disputes between them in this case. It is anticipated that the terms of said agreement will be fulfilled on or before December 15, 2006, after which time AT&T Missouri would withdraw its objections to MultiBand's application for STS certificate of service authority in this case. Therefore, Moving Parties request that the Commission hold this case in abeyance. In the event the settlement terms are not fulfilled by December 15, 2006 as anticipated, Moving Parties propose to submit a Status Report in this case on or before December 29, 2006.

The Staff of the Public Service Commission of Missouri has no objection to this Motion. The Office of Public Counsel has not participated in this case.

WHEREFORE, MultiBand, Inc., and AT&T Missouri respectfully request that the deadline for filing a procedural schedule in this case (currently October 26, 2006) be set aside, and that the case be held in abeyance temporarily, but at least until December 29, 2006.
