## ORDER OPENING A WORKING CASE TO STUDY POSSIBLE CHANGES TO THE COMMISSION'S RULES REGARDING MANUFACTURED HOUSING AND SCHEDULING A WORKSHOP MEETING

The Commission's Manufactured Housing and Modular Units Program is responsible for regulating construction, safety, and installation standards for factory-built HUD-Code Manufactured Homes and Modular Structures built under the International Residential Code (IRC), as well as for one and two family residential homes and modular commercial, residential, industrial, and educational structures built under the International Building Code (IBC). The regulated industry has approached the Manufactured Housing Department to ask the Commission to revise the regulations that apply to installation and monthly reporting requirements for both HUD and Modular residential homes. The rule changes under consideration directly affect the regulatory time-frame for the installation of the homes and the monthly reporting requirements for manufacturers, retail dealers, and installers of both HUD and Modular manufactured homes. The rule changes will not affect commercial modular structures built under the IBC.

To further its examination of the rules, the Commission will seek input from the manufacturers, dealers, and installers affected by the rule. To start the process, the Commission will schedule a workshop meeting for February 28, 2012, at 2:00 p.m., in Room 305. The Commission invites all interested persons to attend.
