Enclosed with this electronic filing are the Qwest Communications Company, LLC ("QCC") Missouri P.S.C. Tariff No. 5 pages for local exchange services provided by Qwest Communications Company, LLC. These revisions are filed in accordance with Missouri Public Service Commission Rules and Regulations and electronically submitted with a July 1, 2011 issue date and a proposed effective date of August 8, 2011.

The filing proposes the approval of the Company's fictitious name d/b/a CenturyLink QCC. Qwest Communications Company, LLC d/b/a is properly registered with the Missouri Secretary of State's office, and is "Active and in Good Standing" with that office. As required by 4 CSR 240-2.060(5)(B), evidence of registration which was filed with the Secretary of State has been provided to the Missouri Public Service Commission under separate cover.
