SBC Missouri,¹ respectfully requests the Missouri Public Service Commission (“Commission”) to deny Mid-Missouri Telephone Company’s (“Mid-Missouri’s”) Motion to Consolidate this new complaint into Case No. TC-2002-57, which has already been heard, fully briefed and submitted for final Commission determination.

1. On October 27, 2005, Mid-Missouri filed a Motion to Consolidate this case into Case No. TC-2002-57. This Motion appears to be identical to the Motion to Consolidate Mid-Missouri previously filed with its Complaint and served on SBC Missouri on September 23, 2005.




