RE: Notification of Name Change of Sprint wireless subsidiary and ETC, Virgin Mobile USA, L.P., to Assurance Wireless USA, L.P.

Dear Secretary:

Virgin Mobile USA, L.P. d/b/a Assurance Wireless brought to you by Virgin Mobile is an Eligible Telecommunications Carrier (“ETC”) in Missouri pursuant to an Order in File No. RA-2012-0264, effective March 4, 2013. In accordance with 20 CSR 4240-31.015(2), the purpose of this letter is to provide notice and inform the Commission that one of Sprint’s wireless subsidiaries Virgin Mobile USA, L.P. d/b/a Assurance Wireless brought to you by Virgin Mobile (“Virgin Mobile”), is changing its name to Assurance Wireless USA, L.P.

Pursuant to 20 CSR 4240-31.015(2)(A), a clear statement of the old name and new name follows. On February 18, 2020, Virgin Mobile USA, L.P. d/b/a Assurance Wireless brought to you by Virgin Mobile, a Delaware limited partnership, underwent a name change to become Assurance Wireless USA, L.P., also a Delaware limited partnership. The name change to Assurance Wireless USA, L.P. was accomplished through the filing of a Certificate of Amendment of Limited Partnership in Delaware. No other changes to the entity occurred, including any merger, transaction, or other structural change, nor were there any changes to the ownership or operations of Virgin Mobile (now Assurance Wireless USA, L.P.)

Pursuant to 20 CSR 4240-31.015(2)(B), attached hereto as **Exhibits 1 and 2**, respectively, are copies of Assurance Wireless USA, L.P.’s Delaware Certificate of Amendment of Limited Partnership, and Assurance Wireless USA, L.P.’s evidence of registration of the new name with the Missouri Secretary of State.

Pursuant to 20 CSR 4240-31.015(2)(C), the company will continue to comply with all applicable laws and rules relating to ETC designation.

Pursuant to 20 CSR 4240-31.015(2)(D), the company’s contacts in EFIS have been reviewed and are correct.

This name change will have no customer impact – no current Lifeline rates, terms or conditions of service will change as a result of the name change to Assurance Wireless USA, L.P.

In addition, the name change will not be confusing to customers because Virgin Mobile's Lifeline service operates under the brand name "Assurance Wireless brought to you by Virgin Mobile." The name change to Assurance Wireless USA, L.P. simply aligns the name of the legal entity with the familiar brand name.

Pursuant to 20 CSR 4240-31.015(2)(E), attached hereto as **Exhibit 3** is a draft customer notice, which will be sent to Virgin Mobile's Missouri Lifeline customers via SMS text message over the next thirty days informing them of the name change

Accordingly, Virgin Mobile respectfully request that the Commission change Virgin Mobile's name to Assurance Wireless USA, L.P. on all applicable Commission records and otherwise take notice of the actions described herein pursuant to 20 CSR 4240-31.015(2).





Notice to Assurance Wireless Customers

NOTE: This message shall be sent through text message to all of the Company's Lifeline Service customers. Industry consensus and the Parties' own experience is that notice to prepaid wireless Lifeline customers is most effectively achieved through electronic means rather than by U.S. mail. These customers tend to be transitory, often moving without promptly updating their addresses. As a result, mailed letters frequently do not reach them. Moreover, wireless Lifeline customers commonly indicate that they prefer to be contacted by text (or email if available) and are more responsive to such contacts (e.g., in the context of annual recertification). Ongoing communications between the Company and its wireless Lifeline customers, whether for day-to-day customer service inquiries or completion of required Lifeline procedures (e.g., recertification) typically occur via text and/or phone call. For these reasons, the Company intends to send notice to the affected Assurance Wireless customers via SMS (text) messages that will alert them of the Company's name change.
