- 1. Statement of Name Change: Per the Notice Letter dated November 13, 2012 and filed with the Commission, DIECA Communications, Inc. d/b/a Covad Communications Company ("Covad") has changed its name to MegaPath Corporation.
- 2. Secretary of State Name Change: Evidence of registration of the name change with the Missouri Secretary of State was attached as Exhibit A to the Notice dated November 13, 2012, and filed with the Commission on November 15, 2012.
- 3. Customer Notice: A copy of the Customer Notice sent to all of Covad's customers is attached hereto as Exhibit B.
- 4. Adoption Notice and Revised Tariff Sheet: A copy of the Adoption Notice and Revised Tariff Sheet is attached hereto as Exhibit C. The effective date is ten (10) days from the date of this filing.
- 5. EFIS: At the time of filing the original Notice Letter, dated November 13, 2012 and filed with the Commission on November 15, 2012, MegaPath had confirmed

that the contact information was correct in the Commission's electronic filing and information system ("EFIS"). MegaPath again confirms that the contact information is correct. However, MegaPath was not able to change the Company name; it appears that the Commission will have to change the Company's name for the CLEC/IXC and iVoIP screens.
