Dear Mr. Woodruff:

This letter is submitted on behalf of Spectrotel, Inc. d/b/a Touch Base Communications ("Spectrotel" or "Company") to notify the Commission that the Company has changed its name to Spectrotel of the Midwest LLC. The Company respectfully requests that the Commission issue an updated certificate, if applicable, to reflect the Company's name as "Spectrotel of the Midwest LLC d/b/a Touch Base Communications" and change the Company name in all Commission records.

Spectrotel was authorized to provide Local, Non-switched Local, and Interexchange Telecommunications Services in Missouri on January 13, 2012 in File No. LA-2012-0169. The Company recently completed an internal corporate reorganization resulting in the creation of a new affiliate, Spectrotel of the Midwest LLC, which will become the telecommunications service provider for the Company's Missouri customers. The corporate reorganization will not impact customers, and service will continue under the current rates, terms, and conditions; therefore, customer notice is not provided.

Attached as Exhibit A are copies of the Certificate of Registration and Registration of Fictitious Name on file with the Missouri Secretary of State. Attached as Exhibit B is the Adoption Notice for P.S.C. MO No. 2 (Access) along with a revised Title Page for the tariff.


