Re: Qwest Communications Corporation- Change in Name to Qwest Communications Corporation, LLC Due to Conversion to Limited Liability Corporation

Dear Ms. Dale:

Qwest Communications Corporation ("QCC") hereby provides notice of a change in name to Qwest Communications Corporation, LLC, due to its conversion from a corporation to a limited liability company ("LLC"), pursuant to Delaware law (the Delaware Limited Liability Company Act ("DLLCA")).¹ The company will be named Qwest Communications Company, LLC. ("Qwest LLC") after January 2, 2009. There will be no change to QCC's operations as a result of this transaction other than the conversion from a corporation to a limited liability company and slight name change. This corporate conversion and name change will be seamless and transparent to, and have no effect on, QCC customers. QCC expects to complete the transaction, and all required approvals, on or about January 2, 2009.

Pursuant to 4 CSR 240-2.060(5), 4 CSR 240-3.020(1), 4 CSR 240-3.545(20), the following information is provided:

(1) The current name of the company is: Qwest Communications Corporation.

The new name of the company is: Qwest Communications Company, LLC.

(2) Evidence of registration of the name change with the Missouri Secretary of State will be provided when available. An explanation regarding the timing of the conversion and commencement of use of the new name is provided below.

(3) An adoption notice and revised tariff title sheet reflecting 30-day effective dates for each of QCC's three current tariffs have been filed in EFIS and assigned tariff File Nos. JX-2009-0322 for Qwest's Missouri P.S.C. Tariff No. 1, JC-2009-0323 for Qwest's Missouri PSC No. 5, and JX-2009-0324 for Qwest's Missouri P.S.C. Tariff No. 4. The tariff pages bear a proposed effective date of January 2, 2009, in excess of the 30-day effective dates required. The

rationale for the tariff effective date is explained below. Specimen copies of the tariff sheets (without issued and effective dates) are attached.

(4) This name change is not a “name change affecting customer recognition of the company” under 4 CSR 240-3.545(20) and thus does not require notice to customers. Nevertheless, QCC will provide customers with notice of the name change in the form of a message on customer’s monthly bills or a letter or postcard to customers.

The conversion from corporation to limited liability corporation is expected to be completed on approximately January 2, 2009, and thus the certificate of formation or good standing as an LLC from the Delaware Secretary of State will not be available to file with the Missouri Secretary of State until after that date. Thus, it is not possible for QCC to obtain and file a certificate of authority to do business from Missouri Secretary of State until after January 2, 2009. That documentation should be available to file within 14 days following the conversion. As soon as the Delaware documentation is available, QCC will make all appropriate filings with the Missouri Secretary of State. As soon as “evidence of registration of the name change” from the Missouri Secretary of State is available, QCC will submit that documentation to the Commission.
