1. In addition to the waiver of rules requested in paragraph 10 of Socket's Application filed herein, Socket further requests that the Commission waive rule 4 CSR 240-32.050(4)(B) to the extent that it approved waiver of the aforesaid Rule in connection with Southwestern Bell Telephone Company's d/b/a AT&T Missouri's Application for Waiver of the General Distribution Requirement of White Page Directories Under Rule 4 CSR 240-32.050(4)(b) (File No.: IE-2009-0357).
