1. SNGMO conducts business as a "gas corporation" and a "public utility" as those terms are defined at § 386.020, RSMo, and provides natural gas service in the Missouri counties of Benton, Caldwell, Camden, Daviess, Douglas, Greene, Harrison, Howell, Laclede, Miller, Morgan, Pettis, Stone, Taney, Texas, Webster and Wright, subject to the Commission's jurisdiction as provided by law.

2. Commission Rule 4 CSR 240-4.017 provides, in part, as follows:

(1) Any person that intends to file a case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case.

4. SNGMO is in the process of negotiating an amendment and restatement of its existing Credit Agreement and plans to enter into a new senior secured term loan facility.
