NOTICE OF ERRATA TO ANNUAL INTEGRATED RESOURCE PLAN UPDATE

COMES NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“EMM”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“EMW”) (collectively, “Evergy,” or the “Company”), and for their respective *Notice of Errata to Annual Update* (“Errata”), states as follows:

1. On June 15, 2023, EMM and EMW filed their respective Integrated Resource Plan (“IRP”) Annual Update (“IRP Update”)
2. After filing, the Company discovered errors in tables within the Executive Summary, as detailed below. Preferred Plan summaries in other sections of the IRP Updates are correct.

EMM IRP Update: Corrected the indicated portions of Table 4 as follows:

3. Included with this Errata are corrected versions of EMM’s and EMW’s respective IRP Updates, as indicated above.

4. There are no changes to the appendices filed with EMM’s and EMW’s respective IRP Updates.
