PUBLIC SERVICE COMMISSION

COMES NOW Union Electric Company (Company) and in clarification of its Motion to Substitute Revised Tariffs for Tariffs Filed and Suspended states as follows:

1. On April 9, 1982 Company filed in this docket its Motion to Substitute Revised Tariffs for Tariffs Filed and Suspended (Motion to Substitute). By that Motion to Substitute Company sought to substitute revised tariffs for Electric Power Purchases From Qualifying Facilities.
2. Said revised (1) tariffs reflected changes made to the originally filed tariffs in response to comments received by Company from Commission Staff and (2) updated the rates to reflect 1982 costs.
3. It was the intent of Company that the revised tariffs be substituted for those originally filed in this docket and without the necessity of beginning a new docket. Stated another way, it was not the intent of Company to formally withdraw its earlier filed tariffs and initiate a new proceeding. Rather, Company, through its Motion to Substitute and attached exhibit, was merely filing modified tariff sheets which reflected discussions with the Commission Staff and updated cost data.

WHEREFORE for the reasons herein stated, as well as those stated in Company's Motion to Substitute, Company respectfully requests this Commission substitute those tariffs contained in Exhibit A to Company's Motion To Substitute Revised Tariffs For Tariffs Filed and Suspended

for those previously filed in this matter as an original Schedule 1, Schedule of Rates For Power Purchases From A Qualifying Facility. Further, Company requests that the updated cost data contained therein be found to relieve Company from any obligation to further update these tariffs on or before January 15, 1983.
