- 1. On February 1, 2001, the Commission issued its *Order Establishing Procedural*Schedule that directed the parties to file surrebuttal testimony by 3:00 p.m. on March 21, 2001.
- 2. The parties to this matter are continuing to pursue settlement discussions.
