**ORDER DIRECTING FILING**

This order directs Staff to inform the Commission when they expect to file the proposed amendments to Rules 4 CSR 240-33.010 through 33.080, 33.110 and 33.150.


On March 27, 2001, Staff of the Missouri Public Service Commission filed a Motion for Finding of Necessity for Rulemaking. On April 12, 2001, an Order Finding Necessity for Rulemaking was issued by the Commission. No further action has occurred in this case since that date. The Commission shall direct Staff to file a pleading informing the Commission when they expect to file the proposed rulemaking documents authorized by the Commission's order.

**IT IS THEREFORE ORDERED:**

1. That the Staff of the Missouri Public Service Commission shall file a pleading with the Commission, informing the Commission of when they expect to file the proposed rulemaking in Case No. TX-2001-512, no later than November 19, 2001.

2. That this order shall become effective on November 8, 2001.

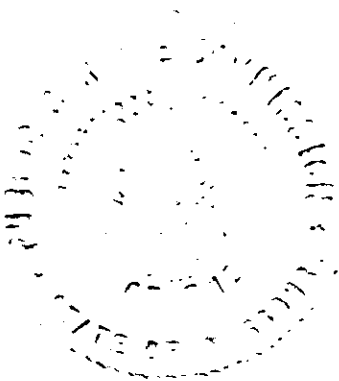
