COMES NOW Union Electric Company d/b/a Ameren Missouri (the "Company") and pursuant to 4 CSR 240-2.070(15)(H) respectfully offers the following limited comments to the Recommended Report and Order issued in this complaint on May 2, 2019.

1. Ameren Missouri supports the Conclusions of Law set forth in the Recommended Report and Order.

2. Ameren Missouri respectfully suggests that the Commission consider revising certain Findings of Fact and references to the evidentiary record set forth in the Recommended Report and Order, as follows:

a. At paragraph 61 of the Findings of Fact, changing the date October 10, 2018 to October 31, 2018, because October 31, 2018 is the date by which the referenced payment was due, as reflected on p 13 of Ex. 103C.

b. At footnote 61 of the Findings of Fact, changing the reference to the supporting exhibit from Ex. 105C to either Ex. 101C or Ex. 103C—in order to reference an exhibit that details the service charges referred to in paragraph 62.

c. At paragraph 67 of the Findings of Fact, changing the reference to the date that the December 11, 2018 bill was due from December 12, 2018 to January 4, 2019, as reflected in Exhibit 103C, p. 19.

Wherefore, Ameren Missouri respectfully requests that the Commission consider these comments to the Recommended Report and Order.
