NOTICE OF CORRECTION

COMES NOW The Empire District Electric Company (“Liberty”), and for its Notice of Correction, respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1. On November 9, 2020, Joint Comments were filed herein by Ameren, Evergy, and Liberty. Empire-specific information was contained in Attachment C to the Joint Comments.
2. The Joint Comments contained the following erroneous response on page six of Attachment C1:

Provide a 5-year historical summary of energy and/or capacity payments related to the existing cogeneration rule and net-metering rule.

At this time, our contracts and agreements are housed under the Net Metering (NM) rule, although those credits are being paid out at the CP rate. Over the past 5 years, we have paid out a total of \$5,465,488.04 in energy credits to Net Metering customers.

3. Upon further investigation and internal review of net metering credits, it has been determined that the correct amount is \$251,212 (see attached).
4. The corrected statement regarding a five-year historical summary of energy and/or capacity payments related to the existing cogeneration and net metering rule is as follows:

At this time, our contracts and agreements are housed under the Net Metering (NM) rule, although those credits are being paid out at the CP rate. Over the past 5 years,

we have paid out a total of \$251,212 in energy credits to Net Metering and Cogeneration customers.

WHEREFORE, Liberty submits this Notice of Correction and requests such relief as is proper under the circumstances.
